



## Introduction

Austin Metals Limited (**Austin** or the **Company**) is committed to implementing sound standards of corporate governance.

In determining what those standards are, the Company has had regard to the ASX Corporate Governance Council's Corporate Governance Principles and Recommendations – Fourth Edition (**Recommendations**).

The Company will be reporting against the Fourth Edition of these Principles and Recommendations for its current financial year, which commenced on 1 July 2024.

The Company's Board governs the business on behalf of shareholders as a whole with the prime objective of protecting and enhancing shareholder value. The Board is committed to, and ensures that:

- (a) management runs the Company, and its subsidiaries (the Group), with a high level of ethics and integrity;
- (b) the Board and management complies with all applicable laws and regulations;
- (c) the Company continually reviews the governance framework and practices to ensure it fulfils its corporate governance obligations.

Further, the Company's Remuneration and Nomination Committee Charter requires the Remuneration and Nomination Committee (or, in its absence, the Board) to ensure appropriate checks (including checks in respect of character, experience, education, criminal record and bankruptcy history (as appropriate)) are undertaken before appointing a person, or putting forward to security holders a candidate for election as a Director.
